## **SINGAPORE SPACE AND TECHNOLOGY LTD'S MEMBERSHIP ("MEMBERSHIP")**

### **MEMBERSHIP TERMS AND CONDITIONS**

Singapore Space and Technology Ltd, formerly Singapore Space & Technology Association is referred to herein as "SSTL". "Member" refers to the applicant.

Each member, including its employees, officers, and directors, agrees to abide by the terms and conditions, as set forth below. Failure to comply with the Terms and Conditions may result in the suspension or termination of Company's membership.

#### **1. Personal Data Protection Act**

- a. SSTL may, at its sole discretion, publicize the member in the membership programme. SSTL may also use the member's logo and name. Member shall not use the name of SSTL and any of the entities within the SSTL group of companies as an endorsement or reference without the prior express written consent of SSTL.
- b. SSTL may collect certain information about the member through this agreement or other related information. In the process, SSTL may also collect business contact information of employees of the member's company.
- c. SSTL may use the business contact information of the member including its name and email address to conduct direct marketing in relation to promotion of and invitation to other events organised or managed by SSTL or its affiliates. Member may choose not to receive promotional materials by informing SSTL in writing and SSTL will cease to do so.

#### **2. Indemnity and Liability**

- a. To the extent permitted by law, member agrees to release, fully indemnify, and keep fully indemnified, SSTL (including its officers, employees and agents) from and against all liability, cost, loss, damage, expense, claim or other right of action arising out of, or in connection with this Application to join SSTL as a member.
- b. Member shall indemnify, defend, and hold harmless SSTL, its officers, directors, employees, contractors, sub-contractors and agents from and against any and all liabilities, obligations, losses, damages, fines, claims, demands, judgments, penalties, costs and expenses (including without limitation legal fees and costs) incurred by SSTL arising, directly or indirectly, from a breach of this Agreement by the member and any act or omission of the member, its agents, employees or contractors.
- c. SSTL shall indemnify, defend, and hold harmless member, its officers, directors, employees, contractors, sub-contractors and agents from and against any and all liabilities, obligations, losses, damages, fines, claims, demands, judgments, penalties, costs and expenses (including without limitation legal fees and costs) incurred by member arising, directly or indirectly, from a breach of this Agreement by SSTL and any act or omission of SSTL, its agents, employees or contractors.

#### **3. Changes of Terms and Entitlements**

- a. SSTL may change both the membership entitlements and terms and conditions at any time with or without notice and each member's continued participation in the SSTL shall be considered acceptance of such changes.
